FASEA Exam



- The exam will test the practical application of advisers' knowledge in the following competency areas:
 - Financial Advice Regulatory and Legal requirements
 - Financial Advice Construction
 - Applied ethical and professional reasoning and communication

FASEA Exam



- Selected response and written response style questions
- at least 70 questions in the examination, split between
 - o at least sixty-four (64) selected response style (multiple choice) and
 - at least six (6) written response style (case study style)

Duration:

- 3.5 hours including at least 15 minutes of reading time **Results:**
- available between 6 and 8 weeks after sitting the exam
- 'Pass' or 'Fail'
- Send results to <u>cpd@interprac.com.au</u>

Pass Mark:

• Set by an expert review panel using standard setting procedures aligned to the range of a typical university credit grade i.e. 64%-74%



FASEA Exam



Next exam dates:

- 19 23 September 2019 (registration period 12 30 August 2019)
- 5 9 December 2019 (registration period 21 October 8 November 2019)
- At least six sittings scheduled in 2020

Note: Exam sitting dates include weekends and there are two sittings per day

• Sydney, Canberra, Melbourne, Brisbane, Townsville, Adelaide, Perth, Darwin, Hobart

NEW Locations (Dec Sitting)

Fees:



Interprac Adviser from WA

Experience and Qualification:

- Accountant and Tax Agent in public practice for 30 years, financial adviser for 3 years
- completed an Advanced Diploma of Financial Planning

Exam prep:

- reviewing the materials prescribed/recommended by FASEA as "suggested reading" in their Exam preparation guide
- materials, however, are quite extensive and overwhelming in volume
- read through some of the most relevant parts one or twice, which was really time consuming

Opinion:

"thought initially 3.5h exam would be plenty of time but I only finished about 5 minutes before the end"

"a lot of the multi-choice questions seem confusing where more than one answer could potentially have been correct, but I suspect well experienced advisers in the industry might find it potentially somewhat easier"

Exam prep:

- reviewing the guidance and outline provided by FASEA
- reviewing all of the readings and regulatory guides including standards provided by FASEA
- Working through the practice exam twice

Opinion:

"exam itself was very accessible and approachable for an adviser who has an interest in the advice process and has done some sort of reading in preparation"

"I have found it hard to judge my result of the exam thus far as many of the questions appear to be easily answered by perhaps 2 of the 4 multiple choice responses."
